### Terms & Conditions

#### 1. Eligibility

Participation in the Maharashtra State Lotteries "Vaibhavlaxmi" scheme is open exclusively to individuals aged 18 years and above who are residents of India and legally permitted to participate in state-authorized lotteries.

#### 2. Ticket Validity

Only original, untampered, and duly authorized tickets issued by designated agents and vendors are deemed valid for participation. Tickets that are mutilated, defaced, duplicated, or otherwise compromised shall be considered void and ineligible for prize claims.

#### 3. Prize Claim Procedure

Winners are required to submit valid proof of identity, address, and ownership of the winning ticket to claim their prize within 30 days of the draw date. The Department reserves the right to verify the authenticity of any claim and may withhold disbursement pending such verification.

#### 4. Taxation

All winnings are subject to deductions as per applicable Income Tax laws of the Government of India. Taxes, if any, will be deducted at source in accordance with Section 194B of the Income Tax Act, 1961.

#### 5. Winning

The **Maharashtra State Lotteries** is a game of pure chance. Purchase of a lottery ticket does not ensure or imply the prospect of winning. Odds of winning are based solely on chance and ticket volume.

#### 6. Disclaimer and Risk Acknowledgment

All participants engage in the lottery at their own risk and discretion. The Government of Maharashtra and its officials shall not be held liable for any monetary loss, misrepresentation, fraud, or damage arising from participation in this scheme.

#### 7. Prohibition of Fraudulent Activities

Any form of misrepresentation, forgery, or unauthorized duplication of tickets will result in legal action and permanent disqualification from participation. Such acts are punishable under relevant Indian laws.

#### 8. Jurisdiction

All disputes, controversies, or legal matters related to this lottery shall fall exclusively under the jurisdiction of the Hon'ble Courts at **Maharashtra, India**.
